THE PROGRAM WHICH IMPLEMENTS THE DISEASE MODEL OF ADDICTION TO ASSIST RESIDENTS AFFECT CHANGE. THIS IS A COGNITIVE BEHAVIORAL SPIRITUAL APPROACH HELPS RESIDENTS THROUGH THE STAGES OF TRANSITION FROM BEING HOMELESS AND JOBLESS TO OBTAINING EMPLOYMENT AND PERMANENT HOUSING AND A SENSE OF GENERAL WELL BEING.

FIRST PREFERENCE IS GIVEN TO THE HIGH POINT RESIDENT FOLLOWED BY THE GUILFORD COUNTY RESIDENT. CLIENTS GO AN ENTRANCE SCREENING BEFORE BEING ACCEPTED TO THE FACILITY. THEY MUST BE 18 YEARS OF AGE AND CANNOT BE A SEX OFFENDER. THE SHELTER OFFERS 66 BEDS FOR THE GENERAL POPULATIONS, AND TEN BEDS FOR TREATMENT PROGRAM AND SIX BEDS IN THE OVERFLOW DORMITORY. ADDITIONAL MATTRESSES ARE SET UP IN THE COLD MONTHS TO HANDLE THE OVERFLOW.
